**DETAILED EXPLANATION OF THE ITEM/ WHAT IS THIS ITEM/PRODUCT USED FOR etc.**

- The item are used to monitor the neurophysiological responses of the spinal tissue as the surgeon Works in close proximity when removing a spinal tumour.
- The probes are used by the surgeons to directly stimulate the spinal cord and the electrodes are attached to the patient and the machine (that belongs to IALCH Neurophysiology department) to pick up response or potential nerve damage
- The analysis of the neurophysiological waves is done by a qualified Neurophysiologist.

**FEATURES EXPECTED FROM THE PRODUCT TO BE EVALUATED (SCOPE)**

1. The product is sterile. Can only be used by one patient as it directly touches bodily fluid (Cerebrospinal Fluid)
2. The product is not re-usable; the electrodes are micro-electrodes and are placed subcutaneously to pick up micro-stimuli from the cord and therefore would not be sensitive if re-used.
3. The product comes is separate packaging and would be compatible with the machine already purchased by the DOH in the department of Neurophysiology, that is currently under – utilized.
4. The items would contain 1x probe and electrodes.
