- 1.1 **SPECIAL CONTRACT CONDITIONS OF QUOTATIONS**
  - 1.2 The institution is under no obligation to accept the lowest or any quote.
  - 1.3 The price quoted must include VAT (if VAT vendor).
  - 1.4 The department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors.
  - 1.5 The bidder must ensure the correctness & validity of quote, that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk.
  - 1.6 The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract.
  - 1.7 This quotation will be evaluated specification & correctness of information.
  - 1.8 Only offers that comply with or greater than specification will be considered.
  - 1.9 Late quotes will not be considered.
  - 1.10 All products supplied must be valid for a minimum period of six months.
  - 1.11 A bidder not registered on the Central Suppliers Database or verification has failed will not be considered.
  - 1.12 All delivery costs must be included in the quote price, for delivery at the prescribed destination.
  - 1.13 Only firm prices will be accepted. Such prices must remain firm for the contract period. Non-firm prices (including rates of exchange variations) will not be considered.
  - 1.14 In cases where different delivery points influence the pricing, a separate pricing schedule must be submitted for each delivery point.
  - 1.15 If samples / compulsory site inspection / briefing session are required, the supplier will be informed in due course.
  - 1.16 The supplier shall furnish any information, when requested.
  - 1.17 In the event that the tax compliance status has failed on CSD, it is the suppliers' responsibility to provide a SARS pin in order for the institution to validate the tax compliance status of the supplier.
  - 1.18 The supplier shall indemnify the KZN Department of Health (aka the purchaser) against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.
  - 1.19 If the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract.
  - 1.20 The purchaser, may terminate this contract in whole or in part if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract fails to perform any other obligation(s) under the contract, or has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
