Machine specific – details of machine (asset number and serial number: from supplier)
 The tubes are used to pipette radioactive blood samples into for counting on the Wizard Auto Gamma Analyser
 Approximately 40 studies per week are performed to calculate glomerular filtration rates (GFR) to assess kidney function
 on patients either prior to the administration of chemotherapy or on diabetic patients. The blood samples drawn for GFRs
 need to be pipetted into clean tubes that are then placed into the autogamma analyzer to count the radioactive content.
 Each patient requires 4 tubes and caps per study. **The tubes and caps need to be compatible with the Wizard auto
 gamma analyser system.**
