Packaging (unit/box)	Sterile, one use, sterilized with Ethylene Oxide, Set to include 21 gage introducer needle, 018 inch nitinol guide wire and an introducer catheter
Functionality/performance	It reduces the risk of bleeding despite multiple or posterior vessel wall punctures, and may be better tolerated by patients because of their smaller diameter.
Purpose	Micro puncture kits can help obtain large bore peripheral venous access in patients with poor peripheral veins, mitigating the likelihood of venous rupture.
Other:	The micro puncture needle's echogenic nature improves visualization with ultrasonography, providing the most benefit for patients with small vascular structures or aberrant anatomy.
