It is generally not recommended to try and remove a skin cancer completely using a punch biopsy. A punch biopsy generally provides a good overview of the entire skin for the pathologist and usually a 4 mm punch is sufficient.
After the biopsy, the skin sample is fixed in special solution, and thin sections of the tissue are cut and placed on microscope slides. The slides are stained for examination by a doctor (usually a dermalologist or pathologist). Sometimes specialized stains are used to examine for antibodies, immune proteins, and other
markers of certain diseases.
