





Material	Cannula manufactured from Teflon polytetrafluoroethylene/ polyurethane - radio-opaque Latex free - Needle must be stainless steel

Functionality/performance	Triple bevelled needle through cannula. Needle must be flush with a tapered cannula to pass easily through the skin. Cannula must not flange and must be kink resistant. Hub must taper towards cannula to prevent kinking when secured Cannula to advance easily over needle – must have advancing hub/pusher Cannula to re-insert and re-engage over needle easily whilst in use. Hub must be translucent so that flash-back can be easily observed
